## Mentorship Program Welcomes New Lead Donors



CSARN is thrilled to announce that Joan and Jerry Lozinski have agreed to become lead donors of our Mentorship Program. Their sponsorship will begin next year; then, in 2017, the program will officially become the Joan and Jerry Lozinski Mentorship Subsidy Program.

Joan and Jerry have a long history of support for the arts. ## Seniors' Care Program - Case Study #16

This is a true story from the Seniors' Care Advisory Program. An artist [we'll call her Mary] required a monitoring system for her home that she could trigger in case of a medical emergency. The system was going to cost her a few hundred dollars a year, and Mary was hoping to find a way to offset some of the cost. Most medical insurance programs don't cover such a system. There is no government support for it. So Mary called the Seniors' Care Advisory Program hotline.

A nurse answered the phone, listened to Mary, and advised her to ask her doctor for a letter recommending the monitoring system. That way, she could claim the service on her income tax return and lower her tax burden.
